Re: Freedom of Information Act Appeal concerning CIA's 'Operation Gladio'

Dear [REDACTED]

This is an appeal under the Freedom of Information Act.

On December 14, 2000, I requested documents under the Freedom of Information Act. My request was assigned identification number F-2000-02528. On December 28, 2000, I received a response to my request in a letter signed by CIA Information and Privacy Coordinator Kathryn I. Dyer, which denied my request under FOIA exemptions (b)(1) and (b)(3). With this letter I appeal the denial of my request.

The documents that were withheld must be disclosed under the FOIA, because the secrecy exemptions (b)(1) and (b)(3) can only reasonably refer to CIA operations which are still secret today. However, after the information has already been widely discussed by European governments and the European media, and after three years of intensive detailed academic international research on operation Gladio, I, my colleagues, and the interested public now know, that CIA was heavily involved in operation Gladio. It is thus no longer a secret, that the CIA, in cooperation with foreign secret services, set up numerous stay-behind networks in most countries of Western Europe after World War Two (In the appendix I am attaching a list of selected publications on the issue). If you, Mrs. Dyer, raise FOIA secrecy exemptions (b)(1) and (b)(3) in this context, you unwisely deprive the CIA from its voice and the possibility to take a stand in a Gladio disclosure discourse, which will take place regardless whether the CIA decides to participate or not.

Therefore, I am filing this appeal pursuant to subsection (a)(6) of the Freedom of Information Act, as amended (5 U.S.C. 552). As provided in the Act, I will expect to receive a reply to this administrative appeal letter within twenty working days. If you deny this appeal and do not adequately explain why the material withheld is properly exempt, I intend to initiate a lawsuit to compel its disclosure.

Rather than debating the CIA's denials and inconsistencies, I thank you for your consideration of my appeal.
